Summary of Changes to IFB-CO-115286-MCAFEE:

1. Book I: Bidding Instructions

- a. This amendment changes the following section of Book I:

Section 2.3, Bid Delivery and Bid Closing

2.3.1. All Bids shall be in the possession of the Purchaser at the email address given below on or before 12:00 pm / 1200 hours (Brussels Time) on ~~Monday, 7 December 2020~~, **Thursday, 10 December 2020**, at which time and date bidding shall be closed.

- b. No updated document is provided.

2. Book I, Bidding Instructions, Annex A-3, Bidding Sheets

- a. This amendment corrects the descriptions of CLINs 1.3, 1.4, 3.3 and 3.4. The SKU numbers and quantities remain unchanged for these CLINs.
- b. This amendment corrects the description and changes the quantities for CLINs 1.5 and 3.5.
